1 BE IT ENACTED by the Legislature of the Virgin Islands:

2 SECTION 1. Notwithstanding any other law and in accordance with title 31,
3 section 205, Virgin Islands Code, Government owned land that is leased for agricultural
4 purposes in furtherance of the Government’s encouragement of agriculture production in
5 the Virgin Islands, shall be leased according to the following schedule:

7 (a) for 1 to 5 acres per year, not more than \$20 per acre; and

8 (b) for 6 or more acres per year, not more than \$15 per acre.

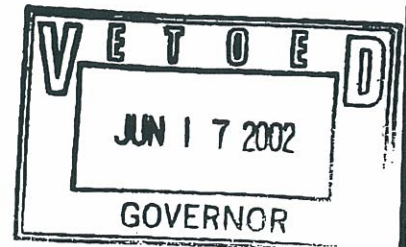

To provide that agricultural land leased from the Government of the Virgin Islands for farming purposes be leased for not more than \$20.00 per acre

BE IT ENACTED by the Legislature of the Virgin Islands:

SECTION 1. Notwithstanding any other law and in accordance with title 31, section 205, Virgin Islands Code, Government-owned land that is leased for agricultural purposes in furtherance of the Government's encouragement of agriculture production in the Virgin Islands, shall be leased according to the following schedule:

- (a) for 1 to 5 acres per year, not more than \$20 per acre; and
- (b) for 6 or more acres per year, not more than \$15 per acre.

SECTION 2. This law shall become effective on June 1, 2002.

Thus passed by the Legislature of the Virgin Islands on May 23, 2002.
