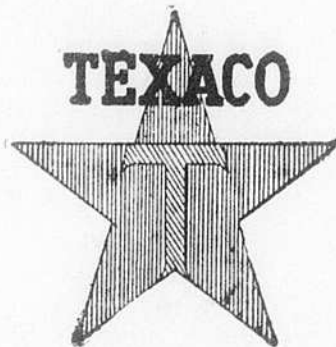

Summons.
