1 BE IT ENACTED by the Legislature of the Virgin Islands:

3 SECTION 1. Notwithstanding any other law, there is appropriated the sum of
4 \$2,700,000 from the Union Arbitration Award and Government Employees Increment
5 Fund as a contribution to the General Fund for Fiscal Year October 1, 1999 to September
6 30, 2000.

8 SECTION 2. Each item of appropriation contained in this Act shall be reduced
9 by the sum expended for the objects and purposes of such item between October 1, 1999

1 and the effective date of this Act, which sum was expended pursuant to Section 9(e) of
2 the Revised Organic Act of the Virgin Islands, 48 USC section 1575 (e).
