² Estates are found only in the U.S. Virgin Islands.

³ Place name color corresponds to the place fill color.

⁴ The full BCU code consists of eight digits with an implied decimal point between the sixth and seventh digits. For legibility on this map, the leading zeros have been stripped and the decimal point is shown. To translate a BCU number on the map to its full code, add as many zeros as needed to the left side of the number to reach eight total digits and remove the decimal point before the last two digits. Examples:

a) BCU number on the map '37.00' represents BCU code '00003700'

b) BCU number on the map '1190.01' represents BCU code '00119001'

⁵ An asterisk (*) following a BCU number indicates that the BCU number is repeated elsewhere in the BCU.

Due to space limitations, some road names, along with other feature and geography names on the map, may not be shown.

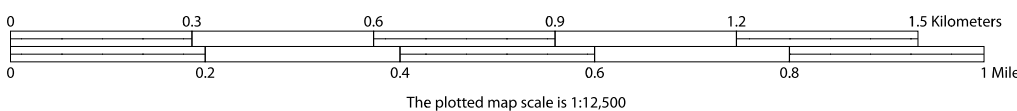
