PROCEEDINGS OF THE COLONIAL COUNCIL FOR ST. CROIX.

Fourth Council, Second Session, 1924-1925

(Continued from Saturday's Avis.)

Election of a Secretary.

15 voting tickets were handed in.

3rd Appointed Member (Armstrong) was elected with 10 votes.

3rd Member for Christiansted Town (Alexander) received 5 votes.

Election of an Assistant Secretary.

15 voting tickets were handed in.

2nd Member for Christiansted Country District (Berg) received 4 votes, 3rd Member for Christiansted Town (Alexander) 3 votes, 3rd Member for Christiansted Country District (Robt. W. Skeoch) and 1st Member for Frederiksted Country District (Fleming) 2 votes respectively and 1st Appointed Member (Coulter) and 1st Member for Christiansted Town (Abramson) 1 vote respectively.

As none had majority vote a new free vote had to be taken.

15 voting tickets were handed in; one was invalid.

2nd Member for Christiansted Country District (Berg) and 1st Member for Frederiksted Country District (Fleming) received 4 votes respectively, 3rd Member for Christiansted Town (Alexander) and 3rd Member for Christiansted Country District (Robt. W. Skeoch) 2 votes respectively and 1st Member for Christiansted Town (Abramson) and 4th Appointed Member (Blackwood) 1 vote respectively.

As none had absolute majority vote a new free election had to take place between 2nd Member for Christiansted Country District (Berg) and 1st Member for Frederiksted Country District (Fleming).

15 voting tickets were handed in.

1st Member for Frederiksted Country District (Fleming) was elected with 10 votes.

2nd Member for Christiansted Country District (Berg) received 5 votes.

Election of a Chaplain.

13 voting tickets were handed in.

Rev. Christensen received 6 votes, Rev. Banks, Rev. Mayhew and Father Clair received 2 votes respectively and Rev. Pigott 1 vote.

As none had absolute majority vote a new free vote had to be taken.

14 voting tickets were handed in, 2 were void.

Rev. Christensen received 6 votes, Rev. Banks and Father Clair 2 votes respectively and Rev. Mayhew and Rev. Allen 1 vote respectively.

None having obtained absolute majority vote a new vote was taken between Rev. Christensen, Rev. Banks and Father Clair.

11 voting tickets were handed in.

Rev. Christensen was elected with 8 votes.

Rev. Banks received 2 votes and Father Clair 1 vote.

Item 2.

Election of Members of the Municipal Committee and Substitutes

The voting took place in this manner: 2 names were written on the voting ticket, the first signified the member of the Committee and the other the Substitute.

For an Appointed Member and Substitute:

14 voting tickets were handed in.

As Member was elected 4th Appointed Member (Blackwood) with 10 votes; as

substitute 3rd Appointed Member (Armstrong) with 11 votes.

1st Appointed Member (Coulter) received 2 votes, 3rd Appointed Member (Armstrong) and 5th Appointed Member (McIntosh) 1 vote respectively as member; 4th Appointed Member (Blackwood) received 2 votes and 1st Appointed Member (Coulter) 1 vote as substitute.

Election of a Member for Christiansted Town and Substitute.

15 voting tickets were handed in.

Elected as member was 2nd Member for Christiansted Town (Canegata) with 12 votes; as Substitute 1st Member for said Town (Abramson) with 10 votes.

3rd Member for Christiansted Town (Alexander) received 3 votes as member and 5 as substitute.

Election of a member for Christiansted Country District and Substitute.

Elected as member was 3rd Member for Christiansted Country District (Robt. W. Skeoch) with 12 votes; as Substitute 1 member for Christiansted Country District (Holger Jessen) with 12 votes.

1st Member for Christiansted Country District (Jessen) received 3 votes as member; 3rd Member for Christiansted Country District (Robt. W. Skeoch) received 2 votes and 2nd Member for said District (Berg) 1 vote as Substitute.

Election of a member for Frederiksted Town and Substitute.

14 voting tickets were handed in, 2 were invalid.

1st Member for Frederiksted Town (Jackson) and 2nd Member for said Town (Merwin) received 7 votes as member and 6 as substitute respectively.

As none had absolute majority vote a new free vote had to be taken.

15 voting tickets were handed in.

Elected as member was 2nd Member for Frederiksted Town (Merwin) with 8 votes; as Substitute was elected 1st Member for said Town (Jackson) with 8 votes.

1st Member for Frederiksted Town (Jackson) received 7 votes as member and 2nd Member of said Town (Merwin) received 7 votes as Substitute.

Election of a member for Frederiksted Country District and Substitute.

14 voting tickets were handed in.

4th Member for Frederiksted Country District (Andersen) was elected as member with 9 votes.

As Substitute 1st Member for Frederiksted Country District (Fleming) received 6 votes, 2nd Member for said District (Curry) 4 votes, 3rd Member for said District (M. M. Skeoch) 3 votes and 4th Member for said District (Andersen) 1 vote.

As none had absolute majority a new free vote had to be taken for a substitute.

14 voting tickets were handed in.

1st Member for Frederiksted Country District (Fleming) was elected as substitute with 9 votes.

2nd Member for Frederiksted Country District (Curry) received 4 votes and 3rd
