An act renaming Contentment Road on the island of St. Croix as “Senator Alicia “Chucky” Hansen Lane” and appropriating \$10,000 from the St. Croix Capital Improvement Fund to the Virgin Islands Department of Public Works to erect the proper signage

Be it enacted by the Legislature of the Virgin Islands:

SECTION 1. Act No. 8950 is amended by adding sections 4 and 5:

“SECTION 4. The public roadway commonly known as Contentment Road on the island of St. Croix is re-named the “Senator Alicia “Chucky” Hansen Lane” in honor of Senator Alicia “Chucky” Hansen’s long-standing legislative legacy and service. The Contentment Road is particularly fitting to be renamed for Senator Hansen since it was along this road that the Legislature of the Virgin Islands was previously located and where Senator Hansen performed much of her extensive service. The Department of Public Works shall, within 90 days of the enactment of this act, erect at each end of Contentment Road, a sign bearing the inscription “Senator Alicia “Chucky” Hansen Lane”.”

SECTION 5. Notwithstanding the use restrictions of the St. Croix Capital Improvement Fund established in 33 V.I.C §3087(a), there is appropriated the sum of

1 \$10,000 from the St. Croix Capital Improvement Fund of the Treasury of the Government
2 of the Virgin Islands to the Virgin Islands Department of Public Works in the fiscal year
3 ending September 30, 2026, to erect the signage authorized in section 4.”

4 **BILL SUMMARY**

5 This bill renames Contentment Road on the island of St. Croix as “Senator Alicia
6 “Chucky” Hansen Lane” and appropriates \$10,000 from the St. Croix Capital Improvement
7 Fund to the Virgin Islands Department of Public Works to erect the proper signage.
