**REPORT AND RECOMMENDATION
CONCERNING PLEA OF GUILTY**

P. 11 and LRCr 56.1(b)(14)(A) and has entered a plea of guilty to Count One of the INFORMATION POSSESSION OF FIREARM WHILE UNDER INDICTMENT.
