FROM THE POLICE.

ALL owners of dogs are enjoined with- in the ending of January month to procure from the Police Office (for Kingshill District from Kingshill Police Station) the signs for dogs prescribed by the Police Regulations, which according to same must always be worn by the dog, and for which Franes 10.00 must be paid for the dogs in town and Franes 2.00 for those in the country.

After said time dogs met not wearing the sign for 1924 will be caught and brought to the Police Office (Kingshill Police Station) and detained for 3 times 24 hours, when it will be killed, unless the owner appears to claim the dog, pays a fine of Franes 15.00 and eventually procure the required sign.

**W**HEREAS, the Municipality of St Croix, by CHARLES H. GIBSON, Government Attorney, has filed in said Court its petition of Escheat in the above entitled cause, setting forth that one ROBERT O. ROBINSON, on the 24th day of November, 1921, died, intestate, in the county of Barnstable, state of Massachusetts, and leaving the real estate, No. 59 King Street, Christiansted, St. Croix, and in addition rental moneys and bonds of the St. Croix Sukkerfabrik, and leaving no heirs, widow, or known kindred capable of inheriting said property, and praying that the aforesaid property be adjudged to belong to the Municipality of St. Croix.

IT IS ORDERED that said petitioner give notice of the pendency of said action by publishing the substance of the said petition as hereinbefore set forth, with this order, in the "St. Croix Avis", a newspaper printed at Christiansted in said Municipality of St. Croix, Six consecutive weeks, and that all persons interested in the aforesaid property appear and show cause, if any they have, on or before the 25th day of February, 1924, why the title should not vest in the Municipality of St. Croix.

IT is hereby made known that the Horse, Carriage and Boat Tax for the first half year 1924 will be received by the Director of Police in Christiansted and Frederiksted from the 20th January 1924 to the 10th February 1924, both days included, after which the list of arrears will be transmitted to the same authority for further measures.

Each debtor of tax will be subject to a fine of Fres. 1.00 if the tax be under Fres. 25.00 and Fres. 2.00 if the tax be Fres. 25.00 or above, besides the ordinary levy expenses.

The taxlists will be distributed by the Police and are to be filled out in conformity with the ordinance of February 22, 1853 and returned to the respective Police Offices within 48 hours in the towns and 4 days in the country.

IT is hereby made known, that the Tax on Auto Vehicles and Auto

Truck Trailers according to Section 31 of the Ordinance concerning Public Roads in St. Croix approved July 14, 1923, will be payable for the first Half Year of 1924 at the Police Offices in Christiansted and Frederiksted from January 20, 1924 to February 10, 1924, both days included.

Parties remaining in arrears for this tax after February 10, 1924, will be subject to the same penalties as in the case of the Horse, Carriage and Boat Tax.

Tax-lists will be distributed by the Police Department and are required to be correctly filled out and returned to the respective Police Offices two days after receipt in the towns and 4 days after receipt in the country.
