To All Who May Be Concerned.

SECTION 256 of the Income Tax Law requires "That all individuals, corporations, or partnerships, in whatever capacity acting, including lessors or mortgagors of real or personal property, fiduciaries, and employers, making payment to another individual, corporation, or partnership, of interest, rent, salaries, wages, premiums, annuities, compensations, remunerations, emoluments, or other fixed or determinable gains, profits, and income of \$1,000 or more during any taxable year * * * shall render a true and accurate return * * * setting forth the amount of such gains, profits, and income, and the name and address of the recipient of such payment."

Employers in St. Croix, who come within the scope of the above provision of the law, will submit the necessary reports to the Despatching Secretary, not later than April, 15, 1922, on forms to be had at the office of the Despatching Secretary or at the office of the Director of Police in Frederiksted.

BEGINNING April 2, 1922, and until further notice, the letter mail for St. Thomas, Porto Rico and the United States, etc., to go forward by the S. S. "Marina" via Frederiksted, will be closed at this office at 10.00 a. m. Sunday. This is only a collection service, and no stamps will be sold; money orders will neither be issued nor paid; mail will not be registered, nor will there be any general delivery of mail, and the mail boxes will be cleared precisely at 10.00 a. m. This service aims at affording the patrons of this office as much time as practicable in which to answer important correspondence received the previous afternoon, and it is not contemplated that letters which could be mailed on Saturday will be held over for Sunday morning. The fact that since the establishment of steamer service the usual quantity of mail has been deposited in the post office on Saturday indicates that Sunday collection service is not indispensable, and co-operation is earnestly invited in this effort to further serve the public. If it should develop that the bulk of mail is held over for mailing on Sunday morning so much work will be imposed on the office that in order to dispatch the mail in due time, it will be imperative to shorten the hours of service.
