By virtue of the power vested in me under 5 App. IV Rule 160 of the Territorial Court of the Virgin Islands, I do hereby appoint the Clerk of the Court as Violations Clerk, whose function shall be in accordance with said Rule, "To accept appearances, waiver of trial, plea of guilty and payment of fine and costs in traffic offenses" hereinafter designated, with Schedule of Fines:
