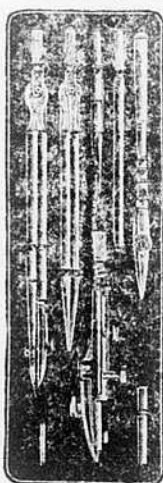
ADMINISTRATOR'S NOTICE
