REPORT AND RECOMMENDATION CONCERNING PLEA OF GUILTY

Defendant Jahvid Alexander (“Defendant”), by consent, appeared before me on **June 10, 2026**, pursuant to Federal Rule of Criminal Procedure 11, Local Rule of Criminal Procedure 1.2, and Local Rule of Civil Procedure 72.3, and has entered a plea of guilty to Count One of the Indictment, a violation of Title 18, United States Code, Section 2119(1) and Title 18, United States Code, Section 2.

After cautioning and examining Defendant under oath concerning each of the subjects mentioned in Rule 11, I determined the guilty plea was made knowingly and voluntarily, and that the offense charged was supported by an independent basis in fact containing each of the essential elements of such offense.
